It is often said, “You do not see the good in something until you have seen the bad.” The aftermath of Harvey, and the recovery efforts that followed, brought to light the giving nature of individuals and the corporate responsiveness of businesses in our communities. When it was most needed, our community once again came together to help our neighbors and our friends overcome and recover.

Southwest Louisiana is a community full of individuals and businesses who believe that investing in the community you call home is the best way to make it a community worth living and working in. Giving USA reported in 2016 that charitable donations by corporations across America grew by 3.5% and individual charitable donations grew 4%.

Hurricane Harvey was not the first time our community came together. In 2005, Hurricane Rita wreaked havoc on Southwest Louisiana. Our community immediately answered the needs of our residents, forming the Human Response Institute (HSRI) at Family and Youth Counseling Agency to help those affected by the storm. Individuals and corporations invested in HSRI to help establish a hurricane response center to connect individuals to the recovery efforts they needed.

Southwest Louisiana has a long history of individuals and organizations coming together in support of initiatives that benefit our community. In 1970, the Junior League of Lake Charles, hearing these needs and answering, established a human services organization that would later become Family and Youth Counseling Agency. For forty-seven years, individuals and corporations, through endowments, donations, and partnerships, have supported and invested in the programs at Family and Youth to ensure their continued legacy and ability to reach those in our community who depend on the services provided.

As we move into the future of our community and continue to bring in businesses and individuals who will call Southwest Louisiana home, we hope that this history of supporting the community, seeing a need and answering the

call will inspire our new neighbors to continue the legacy of philanthropy in Southwest Louisiana has always enjoyed.

Employees of Lake Charles LNG

Lake Charles LNG, previously known as Trunkline LNG, is being developed here in Lake Charles, LA by Energy Transfer. Since their establishment in the community they, along with their dedicated employees, have shown a commitment to give back and serve the community and environment where they are located and where their employees and their families live. It is the employees of Lake Charles LNG who we honor today with the Philanthropist of the Year award.

Over the years the employees of Lake Charles LNG have given their time, talent, and treasure to better Southwest Louisiana. They have shown themselves to be environmental stewards through habitat restoration projects at the Sabine National Wildlife Refuge as well as maintaining an environmentally friendly and compliant facility.

In 2016, Lake Charles LNG and their employees provided funds to the Calcasieu Parish School Board to develop a safe drop-off and pick-up for Prien Lake Elementary, allowing children to get to and from school away from Nelson Road.

They have partnered with SOWELA Technical Community College to introduce industry related skills classes for students who are dual enrolled through the Lake Charles Boston Academy. This initiative has provided students graduating high school with an Industry based credential that allows them to jump start their future careers.

The employees of Lake Charles LNG have also been firm supporters of Family & Youth. For two years, they have been a Leading Sponsor of the Connections Count! Professional Development Conference, supporting education for professionals across Louisiana so that they may continue to serve children, youth, and families.

In addition, they have supported the Children's Advocacy Center (CAC) by participating as a 'hole sponsor' during the Shine Flournoy Golf Tournament, providing vital funds in support of children who have alleged to have been sexually and/or severely abused and have gone to the CAC for services.

They have supported The Leadership Center for Youth's Career Exploration initiative. The Career Exploration initiative gives high school aged youth the opportunity to experience various careers in our community first-hand with facility tours, professional speakers, and experiential activities.

The Employees of Lake Charles LNG established an endowment with Family Foundation that continues to grow because of the consistent employee contribution, and the generous agreement of Lake Charles LNG to match all contributions. Together, employees and company have created a significant legacy for the future of family services in Southwest Louisiana.

The grief initiative provides counseling and resources to children who have lost a significant loved one.

When they meet a child in need of the vital services offered by the Shannon Cox Counseling Center, they will bring them to the facility for services themselves, truly embodying the belief of taking change into your own hands.

They have provided support to the Autism Support Alliance, a division of Family and Youth, for counseling and skills development for children affected by autism or a social skill deficit.

In 2017, Tim & Tammy came to Family and Youth with the desire to put on a Volleyball Clinic and Dinner, with all funds raised supporting The Leadership Center for Youth. Team USA Olympians Nick Lucena and Phil Dalhausser attended a private dinner for event sponsors and then lead a day-long clinic for high school volleyball players in the community. Because of their support, Tim and Tammy raised vital funds to support Leadership Development, Career Exploration, and Civic Engagement initiatives for youth in Southwest Louisiana.

In Southwest Louisiana our economy and our population is rapidly growing and we anticipate an expected increase of 22,000 residents over the next five years, of this increase an estimated 4,400 will be living in distress.

SWLA's growing population is expected to increase by 22,000 over the next 5 years. The demand for our services will increase proportionally.





HOW WE'RE GROWING OUR REACH



We currently have 10 therapists on staff. After our expansion, 5 more therapists will come on board to better serve the needs of our community.



We're **adding 12 new private therapy** offices to our existing 10 offices. With 22 total private therapy offices, we will better serve the need in our area.



More therapists means we will expand our current 100 adult sessions per day to 130 adult sessions per day.



And we're **doubling our reach** for children. We currently counsel 20 children per day and will now have the ability to counsel 40 per day.



Our 50-square-foot play center is **increasing to 90 square feet**.



Two additional training rooms will be added to the new facility. With 3 total rooms, Training will become more efficient.


