This is done in conjunction with the presentation of the audited financial statements. The Finance Committee is a subcommittee of the Board of Directors and is made up of six members with financial and management backgrounds that reviews and votes on all financial transactions of the organization.

02. Conflict of interest policy compliance (Part VI, line 12c)

The Organization annually distributes the code of ethics and disclosure statement forms to the Board of Directors and each member reviews and signs as documented in the minutes of the Board of Director meetings. This form documents that each board member is independent and does not have any conflict of interest.

In an executive session, the Program and Personnel Committee reviews executive compensation history, performance appraisal, and national compensation documents from the Alliance for Children and Families. All discussion is documented in the minutes of the meetings.
