How is this article relevant to CASA?

In its simplest form, parentification occurs when a child assumes adult-like roles and responsibilities. The overarching role of the parentified child can be described as that of caregiver. It is often observed and examined along two dimensions: instrumental parentification and emotional parentification. There are approximately 1.3–1.4 million parentified children aged 8–18 in the United States. This article discuss how parentification can affect children as they grow into adults as well.
