Thank you for choosing Steven M DeRouen & Associates LLC to assist with the 2023 taxes for Family Foundation of Southwest Louisiana. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2023 federal and state income tax returns for Family Foundation of Southwest Louisiana. Our engagement to prepare the 2023 tax returns will conclude with the delivery of the completed returns to management, or with e-filed returns, with the tax matters representative's signature and our subsequent submittal of the tax return.


